## III. EXECUTIVE DIRECTOR'S REPORT

- A. Governing Board News NCISC would like to welcome back and announce the return of Steven Isoye to the North Cook region. Steven will be taking over the helm at Niles Township District 219.
- B. State Funding Update Bruce testified in Springfield in support of Bill HB5025 which would restore funding to the superintendent salary lines for the three Intermediate Service Centers. We remain hopeful this legislation will be passed in the spring. On another note, there is little progress to report in the stalemated Illinois budget situation. We will continue to keep you posted.
- C. North Cook Young Adult Academies (Regional Safe Schools Program) –The closing process for the Palatine campus site has begun and formal notice has been given to District 211. We have met with all staff who will be RIFFed and will serve as positive references for all released staff. One change from the March report is the number of released personnel will fall to 4.2 FTE instead of 5.2 FTE due to an announced maternity leave.
- D. PARCC At this writing the three districts that fell between 90-95% in participation, have been asked to file a short written response with ISBE and ourselves indicating corrective actions to be taken.
- E. Change in Counsel NCISC has decided to recommend a change in counsel effective May 1, 2016 to Ottensen, Britz, Kelly, Cooper, Gilbert and DiNolfo LTD, with G. Robb Cooper as our lead attorney. We want to thank Bob Riley and Robbins Schwartz for their years of service.
- F. NIU Partnership Northern Illinois University has asked Bruce to be part of the superintendent preparation program. Since Bruce currently serves on the partnership committee for the NEIU principal prep program this initiative would also be a positive experience.
- G. NCYAA Calendar Approval Both NCYAA FY17 and NCISC FY17 Governing Board meeting dates are enclosed for your approval.
- H. Sale of the Building We have been advised that Continental Offices is in the process of being sold. However, to date we have no written confirmation of the transaction. We will keep you apprised of the building status moving forward.
