



EVALUATOR RETRAINING REQUIREMENTS

NEW Retraining Requirements for Teacher Evaluators and Principal Evaluators

<p>WHO</p>	<p>The Performance Evaluation Reform Act (PERA) requires ALL evaluators who have taken the initial evaluator pre-qualification training (Growth Through Learning modules) to complete retraining within their next five year renewal cycle following the renewal cycle in which they completed the initial training (105 ILCS 5/24A-3).</p>
